The group's entry into home textiles was strengthened through the acquisition of the woven fabric processing units of Hemlines Textile Export Pvt. Ltd., enabling seamless integration from fabric processing to finished home textile products.

Kanha Worldwide LLP is led by Mr. Kushal Agarwal, focusing on quality, compliance, and global buyer partnerships, while the group's woven garment fabrics division is managed by Mr. Kunal Agarwal. The group also operates a dedicated knitted fabrics vertical through Devdeep Texfab Pvt. Ltd., supported by Aghara Spintex LLP, in which the group holds a minority stake and which supplies yarn and knitted fabrics—ensuring operational focus and clarity across woven home textiles, woven garments, and knitted fabrics.


